A service to support those at risk, or victims of Child Criminal Exploitation, and close family members

10 Pre-Arrest Diversion Scheme (PADS)

PADS is a Community Resolution officers can use to refer individuals found in possession of a personal use quantity of illegal drugs

11 Business Crime

A service to offer practical support to small and medium businesses impacted by crime

12 Drug Interventions

Interventions to identify and address drug and alcohol related issues amongst offenders

13 Floating Housing

Support for adults who have criminal convictions and are experiencing homelessness or facing housing insecurity

14 Space Scheme

Activities for children aged 8-17 living in Staffordshire and Stoke-on-Trent

15 Pause

Pause work with women who have experienced, or at risk of, repeated pregnancies that result in children needing to be removed from their care

16 Personal, Social, Health & Economic (PSHE) Education Service

Support for education providers delivering PSHE education

17 Stalking Support

The Staffordshire Victim Gateway facilitates access for victims into specialist support.

18 Commissioner's Community Fund

The Commissioner makes money available to local Community Safety Partnerships so they can address local community safety and anti-social behaviour issues

Staffordshire Victim Gateway

The Staffordshire Victim Gateway help victims recover from the impact of the crime so they can live fulfilling, independent lives.

The service is the front door for victims of crime providing free, tailored advice, guidance and signposting as well as practical and emotional support, whether the crime has happened recently or in the past.

The Gateway will undertake a managed handover to specialist services based on the needs of the victim.

Survive

Survive offers a free, non-judgmental and confidential service for victims of sexual assault and abuse, as well as close family members and significant others.

Survive is a free, non-judgemental and confidential service providing practical help, advice and emotional support.

Services include a cope and recover specialist support service, including Independent Sexual Violence Advisors (ISVAs) and Children's Independent Sexual Violence Advisors (CHISVAs). A counselling and therapy service (including pre-trial) is also available for victims, as well as close family members and significant others.

Eligibility: Adults and children

Exceptions: Victims of anti-social behaviour (ASB) where there is no criminality or crimes against the state

New Era

New Era provides free, confidential support for all those affected by domestic abuse including adults, children and families.

New Era's Victim Service

Free confidential support is available for victims of domestic abuse, 24 hours a day, 7 days a week by phone or live web-chat. The service also has dedicated specialist advisors working with LGBTQ+; Black, Asian, Minority Ethnic and Refugee (BAMER) communities; male victims and older victims, as well as those with a disability. Specialist support is available for both adults and children.

New Era's Behaviour Change Service

New Era's Behaviour Change service provides help to anyone who is displaying unhealthy or abusive behaviour within their relationship and wants to change this. The service also supports children displaying abusive behaviour towards parents/carers.

New Era's Domestic Abuse in the Workplace Champion Programme

New Era also provides a free of charge, domestic abuse in the Workplace Champion programme, helping employers to support their staff who may be affected by domestic abuse.

Eligibility: Adults & children affected by domestic abuse

New Era is funded by the Staffordshire Commissioners Office (SCO) together with Staffordshire County Council and Stoke-on-Trent City Council, and is operated by Victim Support.

Sexual Abuse Referral Centres (SARCs)

Sexual Assault Referral Centres (SARC) offer free, confidential healthcare and compassionate support to adults and children who have experienced sexual assault, including rape.

SARC services include:

- 24/7/365 acute trauma-informed healthcare and support
- Immediate over-the-phone rape and sexual assault support
- In-person rape or sexual assault crisis support and healthcare including access to medications if needed
- 24/7/365 comprehensive forensic medical examinations
- Collection and storage of forensic samples
- Comprehensive risk assessments
- Referrals to specialist counselling and Independent Sexual Violence Advisors (ISVA) support

Harmony

Harmony helps victims recover from the impact of ASB, whether they choose to report incidents to the Police or not.

Harmony provides a specialist support service, including tailored advice, guidance, information and practical and emotional support.

A confidential, impartial mediation service between both or multiple parties who may be neighbours, near neighbours or community members is also available.

Furthermore, the service offers free training / awareness raising sessions for professionals.

Eligibility: Adults and children

Exceptions:

- Forms of ASB where there is no identifiable victim such as begging / vagrancy, abandoned vehicles, prostitution
- Street parking
- Environmental pollution
- Street noise
- Related matters as a result of concerns around a licensed premise
- Noise deemed to be a result of lifestyle differences or normal living
- Cases where mediation does not relate to ASB e.g. family / marriage

Restorative Justice (RJ)

A free, effective, high quality restorative justice service across Staffordshire and Stoke-on-Trent, which offers a range of victim-led RJ interventions to help victims cope and recover from the impact of crime and the harm they have experienced.

The service also offers training and awareness for professionals.

Please note: officers can refer into the service via Niche.

Eligibility: Adult and children victims and adult offenders

Exceptions:

- Victims and offenders of ASB
- Restorative practice in educational settings
- Offenders under the age of 18 years.

Uniting Staffordshire Against Hate

Uniting Staffordshire Against Hate (USAH) provides a free, confidential advice, guidance and information service, as well as emotional and practical support to all victims of hate crime or incidents.

USAH is available to victims of hate crime / incidents who either live in Staffordshire or were targeted when visiting the area on more than two occasions.

The service also offers free training / awareness raising sessions for professionals.

Eligibility: Adults and children

Exceptions: Cases of discrimination as covered by the Equalities Act 2010

Can Police refer? Yes

Geography: Staffordshire and Stoke-on-Trent, including repeat victims where 2 or more crimes/incidents have occurred in the County but the victim lives out of area

Navigator and Tailored Support

Catch22 deliver a Navigator and Tailored support service to identify and support children and young adults who are involved in, at risk of being involved in, or affected by violence and its associated harms.

Evidence suggests that following a violent or traumatic incident, presentation at hospital or custody, can be a period when individuals may be open to receiving support.

Once identified, the Catch22 Navigator will work with them to build trust and signpost them to appropriate services, or provide direct support through the Tailored Support Service.

Eligibility:

- Police custody: children aged 10-18 years old.
- Hospitals and other healthcare providers: children & young adults aged 10-25 years old.

Child Criminal Exploitation

The service has a strong preventative focus and aims to identify and target children who are **vulnerable** to being criminally exploited.

Action for Children's work focuses on group initiatives and 1:1 support. All referrals are made by schools/education providers. The service will signpost referrals that do not fit the criteria and will be working collaboratively with other agencies to maximise capacity, resources and reach.

Eligibility: 9-16-year-olds (up to 25 for those with special educational needs/disabilities). Support in primary schools will be for years 5 & 6.

Pre-Arrest Diversion Scheme (PADS)

PADS is a Community Resolution officers can use to refer individuals found in possession of a personal use quantity of illegal drugs to specialist support, offering offenders the opportunity to address their drug use. Initial Assessments are via phone.

A one-to-one assessment is conducted to identify the needs of the individual and to provide help in accessing support services for any needs. For example: substance use treatment for dependent or problematic drug use; housing; employment; gambling; exploitation; and safeguarding.

Business Crime

The service delivers specialist support to businesses impacted by crime to help them get back on their feet as soon as possible and to prevent them from being a repeat victim of a business crime.

The service, which is delivered by Staffordshire Chambers of Commerce, can support any crime against a business, from theft and burglary through to cybercrime and fraud.

Business Crime Advisors are trained to deliver tailored advice and support to help victims of crime and can also refer them to a number of different organisations that can provide specialist advice and support at no initial cost.

Eligibility:

- Offenders aged 12+
- Offenders must accept responsibility for the possession without a reasonable excuse or statutory defence

Drug Interventions

Drug and alcohol use is known to have a strong correlation with offending behaviour. These interventions are aimed at providing opportunities throughout the criminal justice system to identify and address drug and alcohol related issues amongst offenders.

Support workers are available in criminal justice settings to assess and refer drug and alcohol users into Orders such as Drug Rehabilitation Requirements and Alcohol Treatment Requirements, whilst also engaging them in psychosocial support to address the reasons underlying their substance use.

Staffordshire service: STaRS

Eligibility: Prison release, court orders ATR/DRR, RA, open to Probation/IOM

Stoke-on-Trent service: City Drug and Alcohol Service (CDAS)

Eligibility: Anyone in the criminal justice system in Stoke-on-Trent with substance use issues (children, young people, or adults)

Floating Housing

Offploy support adults who have criminal convictions and are experiencing homelessness or facing housing insecurity to obtain permanent tenancies in the community and provides floating support until they have achieved as much independence as control over their lives as possible.

The support ensures service users have the information they need to enable them to maintain their accommodation/tenancy and provides advice to achieve and maintain independence.

The service focuses on people who have a previous history of offending and are at risk of re-offending. They may also have other support needs, including but not limited to, mental health, drug and alcohol misuse, and/or other addiction issues.

Eligibility: Referrals are accepted for individuals who meet all of the following:

- Have a criminal conviction
- Have an active housing need
- Present with at least one additional barrier such as:
 - Mental ill-health
 - Financial difficulty or debt
 - Lack of employment or training
- Not already receiving equivalent case management support, such as:
 - IPS (Individual Placement and Support)
 - Restart scheme
 - Refuge or specialist housing services
 - Drug and alcohol recovery programmes
- Willing and able to engage for a full 16-20-week period
- Capacity to work towards goals, attend regular check-ins, and participate meaningfully

Space Scheme

The Space scheme provides an opportunity to engage with children during the summer holidays and provides opportunities to help nurture, support and develop them.

By bringing together public, voluntary and private sector organisations Space can offer support to 8-17-year-olds to help increase their skills, improve their health and wellbeing and create opportunities, while also aiming to reduce level of anti-social behaviour.

Hundreds of activities take place each year including swimming and gym sessions, youth club sessions, DJing and wildlife experiences.

Pause

Pause work with women who have experienced, or are at risk of, repeated pregnancies that result in children needing to be removed from their care.

Pause work with women to take control of their lives, breaking a destructive cycle that causes both them and their children deep trauma.

The service offers an intensive, supportive 18-month programme that may involve advocacy and support to help birth family members get their views across when dealing with children's services and other official agencies, counselling or therapeutic support and support groups for birth families affected by adoption.

Pause is joint funded by the SCO with the Stoke-on-Trent City Council and Staffordshire and Stoke-on-Trent Integrated Care Board (ICB).

Personal, Social, Health, Economic (PSHE) Education Service

The Pan-Staffordshire PSHE Education Service supports the development and delivery of age (and stage) appropriate, quality, consistent and inclusive PSHE education across the City and County.

The service helps education providers to build confidence through training, resources and professionals networks and allows parents/carers and children to shape local PSHE provision.

Commissioner's Community Fund

Under the Crime and Disorder Act 1998, Local Authorities have a statutory duty to collaborate with Police and other statutory partners (Fire and Rescue Services, the Probation Service and the Health Service) to reduce crime and anti-social behaviour and increase community safety. As members of local Community Safety Partnerships (CSPs), these organisations produce a Community Safety Plan which outlines the community safety priorities for the local area and the Staffordshire Commissioner provides funding to help CSPs deliver activities in support of these priorities.

This funding is allocated to the nine Community Safety Partnerships (CSPs) and each CSP receives a share of just over £100,000 to address community safety-related concerns, reduce crime and ASB and enhance public confidence.

By financially supporting the delivery of local community priorities through this fund, CSPs are able to build on the good work they are already doing to keep our communities safe.
