006	Resolution Centre - GM will bring back monitoring report on the county-wide operation of the resolution centre during its first 6-9 months. To identify whether it is delivering the level of confidence expected. Contained within Force Performance Report	GM
012	Other Violence Against the Person – Paper to be presented at the next meeting on the crime category 'Other Violence Against the Person'. Identifying what it does and does not include, how it affects crime numbers and where the police should draw the line on what should and should not be investigated as a criminal offence. Contained within Force Performance Report	GM
013	<u>Central Motorway Patrol Group (CMPG)</u> – Paper to be provided to the Commissioner on the recent operation with the CMPG to reduce Theft of Motor Vehicles (ToMV) in the south of the county. Details to include arrest rate and outcome rate for those offenders. See CMPG report	GM
014	<u>Victim Satisfaction; General and Business Crime</u> – Short paper to be received at the next meeting on victim satisfaction for general and businesses crime. To outline in terms of support the differences between what individuals need and what businesses need. Contained within Force Performance Report	GM
015	<u>Drugs</u> – Report to come to the next meeting looking back over the last 2 or 3 years at the differential between possession and the supply. To understand how the picture on drugs has changed during the last couple of years. Contained within Force Performance Report	GM
016	Knife Crime – The Chief Constable indicates that the two differing definitions used by the Force to categorise knife crime cause confusion (national and local). He has placed an action on himself to settle these differing figures. Update received: Staffordshire use the National H/O Definition (9 serious offences) however it is felt by the Knife crime lead for the force Supt Fields, that by looking at the lower level offences where a blade is linked to the crime and also possession of a blade, that the force will be in a better position to prevent the more serious offences which are included in the H/O definition. Through our local definition of knife crime we will be able to identify individuals carrying knives and implement appropriate prevention, education and diversionary tactics ^[1] in cooperation with our partners or prosecutions (where appropriate) before more serious crimes are committed.
