

# COMMISSIONERS INDEPENDENT SCRUTINY REPORT Stop Search 13<sup>th</sup> February 2025

Scrutiny Panel:	STOP SEARCH

Purpose:	The Panel are to check that Stop and Search procedure has been followed and that Body Worn Videos reviewed are compliant with the law and are being used effectively. The panel will focus on:  • Whether Body Worn Video Policy was adhered to, • Whether the principles of GO WISELY were followed, • Whether the principles of JOG were followed.  Note: GO WISELY & JOG Principles available in Appendix 1.
Panel Findings:	The time period selected for the Stop and Search incidents was 01 December 2024 to 20 January 2025. During this period 840 Person Stop and Search incidents took place.  12 Incidents were selected randomly by the panel. A check on the BWV stored, by the Commissioner's Office, indicated that Body Worn Video (BWV) was available for 11 of the 12 selected incidents.  There was no Body Worn Video (BWV) for Occurrence 21240175981. The officer concerned is being contacted by the Force Lead for an explanation.  Of the 10 incidents viewed there were 7 incidents where the execution of the Stop Search was clear, complete and professionally undertaken. The panel felt that the



officers in these incidents demonstrated respect and their explanations to the individuals was clear and distinct, covering all requirements of a well-executed Stop Search. In 3 incidents GOWISLEY was mostly completed and one element appeared to be missing. This may have been due to the poor audio/ clarity of sound due to chaotic detention. In 1 of these incidents the officer failed to indicate the station they were from. In the other 2 incidents the officer delivering the GOWISELY spoke very quickly and the panel were unable to ascertain whether GOWISELY was fully covered.

The information on the Stop Search report indicated the grounds for the Stop Search and this was clear and defined in all incidents scrutinised.

## Observations and Recommendations:

#### **Observations:**

- The panel were impressed with the professional manner displayed in the interaction between officers and detainees.
- In a number of incidents, the GOWISELY was delivered very quickly which made it unclear. If unclear to the panel then it may be unclear to the detainee

#### **Recommendations:**

Remind officers to speak clearly to ensure that detainees fully understand.

#### Force Lead Response:

From Chief Inspector Mark Barlow:

As Force Tactical Lead I would like to thank the members of the Commissioner's Independent Scrutiny Panel for their time and dedication. Having reviewed their observations the force will ensure that officers are reminded about speaking clearly during the Stop Search process through in-depth training that is to be delivered in the near future. In addition, the officer who failed to deploy their Body Worn Video during the Stop Search has acknowledged their mistake and will be monitored by their supervisor in the future regarding this matter.
