Purpose:	The Panel are to check that Stop and Search procedure has been followed and that Body Worn Videos reviewed are compliant with the law and are being used effectively. The panel will focus on: <ul style="list-style-type: none">• Whether Body Worn Video Policy was adhered to,• Whether the principles of GO WISELY were followed,• Whether the principles of JOG were followed. <p>Note: GO WISELY & JOG Principles available in Appendix 1.</p>
Panel Findings:	The period selected for the Stop and Search incidents for this scrutiny was 01 October 2025 to 25 October 2025. During this period 568 Person Stop and Search incidents took place. 12 Incidents were selected randomly by the panel. One of the incidents selected was a vehicle search and therefore not under the remit of this panel. A check on the BWV stored, by the Commissioner's Office, indicated that Body Worn Video (BWV) was available for ten of the twelve selected stop search incidents. There was no Body Worn Video (BWV) for Occurrence 21250165797. The officer concerned was contacted by the Force Lead for an explanation. The officer responded whilst the scrutiny was being conducted and indicated that he had not activated his body worn camera. However, his colleague had, the footage was located, and the panel were able to view the stop search incident.



Incident 21250159438 had BWV footage, but this had been wrongly identified as a Stop Search. No Stop Search took place.

Of the ten incidents viewed there were eight incidents where the execution of the Stop Search was clear, complete, and professionally undertaken. The panel felt that the officers in these incidents demonstrated respect and their explanations to the individuals was clear and distinct, covering all requirements of a well-executed Stop Search. In two incidents GOWISLEY was partially completed. In one incident there was poor audio/ clarity of sound due to very windy conditions. GOWISELY may have been executed but the panel were unable to hear it clearly.

The information on the Stop Search report indicated the grounds for the Stop Search and this was clear and defined in all incidents scrutinised.

Observations and Recommendations:

Observations:

- The panel noted that the BWV camera was poorly positioned in incident 21250152647 and the search of the detained could not be viewed properly.
- The panel recognise that the weather conditions on one of the incidents, 21250165689, affected the audio on the body worn video footage. This meant that the panel were unable to hear whether GOWISELY was clearly executed.
- In incident 21250165937 it was noted that the officer indicated that he had the power to search the contents of the mobile phone. It was clarified that the officer only had the power to seize the phone.
- The panel acknowledge the professional and respectful manner of officers in executing Stop Search. It was noted that the officer in incident 21250157418 was considerate and empathetic to the female detainee.

Recommendations:

- Whilst recognising that situations may be difficult, officers to be cognisant of anything that may impede or impair BWV recording and to be aware of the position of the BWV camera.

Force Lead Response:

Officers who conducted the searches highlighted by the panel have been informed of the observations and advised accordingly. In addition, the force has also issued guidance to all officers regarding stop search related legislation. The force would again like to thank the panel members for their commitment to improving the transparency of the use of stop and search in the Staffordshire area.

21250165116	27/10/2025	Yes	Yes	GOWISELY followed. A thorough search well conducted. Clear and concise delivery.
21250165549	28/10/2025	Yes	Not seen	GOWISELY followed but undertaken by two officers. However, complaints process was not stated. BWV viewed was of the officer who did not conduct the search but who was present and gave details.
21250165689	28/10/2025	Yes	Yes	GOWISELY was followed. The weather conditions were extremely windy which meant that the audio was distorted. Thorough search undertaken.
21250165797	28/10/2025	Yes	Yes	GOWISELY was followed. Thorough search undertaken.
21250165937	27/10/2025	Yes	Yes	GOWISELY followed. Thorough search of detained person. Another officer undertook a search of the detained persons bag and a knife found. Panel questioned whether second officer should have given his details. Officer indicated that he had a power to search the mobile phone. It was confirmed that the officer only had a power to seize the phone.
21250165541	29/10/2025	Yes	Yes	A high risk stop search due to reports of a machete. TASER drawn. GOWISELY followed. Thorough search of several individuals. Not clear whether detainees were advised of the availability of a copy of the search.



Explanation of GOWISELY and JOG

G	Explain Grounds for search
O	Explain the Objective of the search
W	Show their Warrant Card
I	Identify themselves by name
S	Which Station they work from
E	Explain their Entitlement to a copy of the record
L	Under which Legal power is the search being performed
Y	You are being detained for the purpose of a search
JOG	Remove only suspects Jacket , Outer coat , and Gloves

Note: Uniformed Officers do not have to show their Warrant Card.
