

COMMISSIONERS INDEPENDENT SCRUTINY REPORT Use of Force Scrutiny Review 19th October 2023

Scrutiny Panel:	USE OF FORCE

Purpose:	 That the Use of Force policy and procedure has been followed and that Body Worn Video reviewed are compliant with the law and are being used effectively. The panel will focus on: Whether Body Worn Video policy was adhered to. Whether the Use of Force level used was necessary. Whether the Use of Force level used was proportional to the incident. Is the action/behaviour justified. Has it been explained adequately. Has it been recorded properly.
Panel Findings:	The time period selected for Use of Force incidents was from 1 st September 2023 to 30 th September 2023. There were 463 Use of Force incidents recorded in this period. As agreed at the previous scrutiny meeting, all use of force incidents in Custody were removed. These are covered by the Commissioner's Independent Scrutiny Panel for Custody. The panel randomly selected 10 incidents at their pre-meeting on 6 th October 2023. Of those 10 incidents, two did not have body worn video. Chief Inspector Barrow informed the panel that he had contacted the officers concerned for an explanation.



Incident 21230132734 – related to the arrest of an individual who was wanted on warrant for failing to appear at the Magistrates court. Officers were alerted to this following a PNC check on the individual who was compliant. Following arrest, the individual was handcuffed and conveyed to custody. The officer did not activate his BWV during the arrest or compliant handcuffing due to the cooperative nature of the individual. The officer did submit the relevant use of force form to record the use of handcuffs for scrutiny purposes.

Officer has been reminded that body worn camera should be enabled for all planned use of force.

Incident 21230126595 – This incident related to a dynamic response by officer in plain clothes who at the time had no facility to wear BWV which is an overt piece of Kit. Officer documented the use of force used appropriately with completion of use of force form which was able to be scrutinised.

The remaining eight incidents were reviewed. STORM logs of the incidents were provided. Panel members were reminded that the STORM log is a live record of events as they happen and indicate calls and information being provided by officers as the incident unfolds. It is not the investigation record. The STORM logs are provided to give some context to the incident leading up to the use of force being deployed and enables panel members to be cognisant of the situation in determining whether the use of force was appropriate in a potentially quickly developing situation. In most cases, Witness Statements were also provided.

The Incidents viewed are outlined in Appendix 1

The panel noted the following:

- The Scrutiny forms used by the panel as part of the scrutiny process needed to be updated on both sides. This was completed immediately.
- The panel were extremely impressed with the courage of officers in incident 21230135502.
- Following incident 21230127437 the panel would like to know what training officers are given in getting non-compliant detainees in to a police vehicle.
- It was noted that 80% of UOF is compliant handcuffing. The panel decided that for future scrutiny they would focus on other types of force and have only 1 compliant handcuffing to ensure that BWV was used.

The panel agreed the use of force deployed was appropriate and proportional to the situations viewed.



Recommendations:	 The panel requested the updating of the Scrutiny Review form for future scrutiny – completed immediately. The panel would like the two officers in incident 21230135502 to be commended for their courage and bravery in a very challenging and distressing situation. The panel to mainly focus on use of force type other than compliant hand cuffing.
Force Lead Response:	It is always pleasing to see officer's bravery and calmness under stressful and dangerous situations being acknowledged. This is testament not only to those officers but to the dedicated training team that deliver the Operational Personal Safety Training (OPST) across the force. Officers undergo significant initial training and have a 1-day refresher every year. As of April 2024, this is increasing to 2-days. This will see further investment which will include more scenario-based training which will build on the in vehicle protective tactics that are currently trained on the initial course.
