

## ETAP Meeting 24 July 2019

Item 2 (ii)

Since my last report in May, we have concentrated on establishing new thematics to take us to the end of the year. This is part of our forward planning and requirement to work to a strict budget.

ETAP is to adopt a balanced approach to its thematic reviews and this means not to concentrate just on the Force, but also on the Staffordshire Commissioners Office (SCO) and now since August 2018, the Fire and Rescue Service (FARS).

A number of topics have now been proposed by the Force, which combined with some generated from ETAP, has enabled us to confirm to all members on the 27 June, our intent to carry out three thematics with immediate effect.

We are also to undertake a 'Subject Review' later in the year. This will review the progress being made by the force in updating their data records, an area which has been discussed previously at ETAP meetings. ETAP seeks reassurance that it is being completed satisfactorily. This new initiative for the panel is not a full thematic but a short review of the subject with outline summary and recommendations.

Of the remaining topics proposed by the Force, we are planning to undertake 'Children in Custody' and 'Missing Persons' which will commence once progress is seen on the three highlighted above.

Although not containing a great deal of new information, the thematic Progress Register is shown below. This reflects the closure on the ICV Thematic which was completed in 29 hours against the budget of 40. Of note, hours allocated for each review has been 60 hours. Future thematics will need to be managed in 50 hours, the hours saving releasing time to undertake new initiatives but still working within the annual budget allowance.
