Introduction

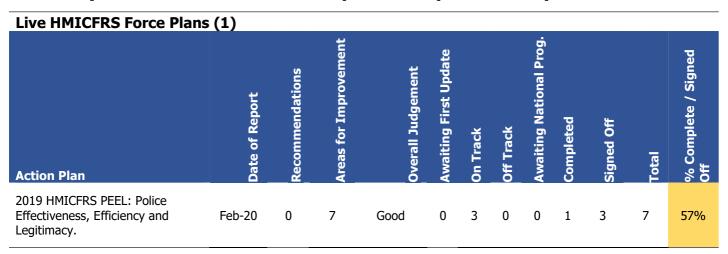
Recommendation to ETAP

Overview of Current Position

1. Her Majesty's Inspectorate of Constabulary and Fire and Rescue Services (HMICFRS) Force Reports

Summary of live HMICFRS force inspection report action plans



Three actions remain open within this plan which relate to wanted persons / PNC, full compliance with the victims code of practice and capability to monitor force computer systems for computer misuse. All of these are being actively progressed and are reported and overseen and the force's monthly Service Improvement Board.

During September 2021 the force was inspected around its child protection arrangements. This was an in depth two week inspection conducted by HMICFRS. The inspectorate gave a 'hot debrief' at the end of the inspection to share early findings with the force although the findings will be subject to a HMICFRS moderation process ahead of the report being published early next year (date tbc). There are a number of areas from the debrief where the force has commenced immediate improvement activity and the appropriate governance and oversight has already been put in place to underpin this. A comprehensive update will be provided to ETAP once the report is in the public domain.

The external audit of the draft statement of accounts for the year ended 31 March 2021 has not yet been completed due to the audit being rescheduled. Therefore the force is not yet able to publish its audited 2020/21 final statement of accounts in line with deadline of 30th September 2021.

5. Strategic Risk Issue and Opportunity (RIO) Management

Since the last report to ETAP the Strategic Risk Management Board has continued to meet bi-monthly.

The current force strategic RIO register has **7 Risks, 2 Issues and 2 Opportunities**. Much activity has been progressed since the December 2020 position was reported and the overview of the current matters held on the register are set out below.

Current Risks:

- **Emergency Services Network**: Risk of compromised operational viability due to delays in decommissioning of Airwave.
- Origin ERP Upgrade: Current version of Origin used by the force is not fit for purpose.
- **Operation Jafar:** Risk to public and officer safety and the ability to deliver service due to Covid-19.
- **Pensions Remedy:** Risk relating to changes of public sector pensions.
- **IT failure:** Risk that infrastructure failure due to end of life hardware may impact on delivery of operational and support activities.
- **Sexual misconduct:** The abuse of position for a sexual purpose
- Operation of BMW N57 & B57 Engine: Recent catastrophic engine failures

Current Issues:

- **Poor Data quality**: Issue relating to the requirement to address inaccurate and incomplete information held across systems.
