**Title** | Technical solution to support Space Programme

#### Summary:

The Space positive activities programme for youngsters aged 11-17 years was introduced by the PCC in 2015, operating during the school summer holiday period as a proof of concept. Funded by the PCC with commissioning of provision by Local Authority partners, Space involved the provision of a range of diversionary activities to reduce levels of police recorded anti-social behaviour and youth crime, and to increase volunteering. Additionally Space aims to promote personal, health and social development, team building and new experiences.

The proof of concept approach was supported by low level technology made available by the police force, which proved to be a significant administrative burden to staff within the Office of the Police and Crime Commissioner (OPCC) as well as Force IT support.

Following evaluation of the successful proof of concept, the Space programme 2016 was planned and introduced. With recognised learnings from 2016, advices received by the OPCC from Force IT recommended the use of templated technology available on line be used to manage, administer and evaluate the programme.

Evaluation following the 2016 provided extremely useful feedback from programme users, providers, partners and indeed OPCC personnel which found the templated approach significantly cumbersome, lacking in flexibility and requiring major IT support to effect its use.

Recognising these major challenges, the OPCC Commissioning and Partnerships Team allocated from budget a maximum value from which to secure the development of a robust, flexible, innovative IT platform to meet the programme technical and marketing requirements, to be owned by the OPCC and utilised for broader growth of Space.

Given the low contractual value, a Request for Quotation process was put in place by IT Procurement to secure the services of an IT development service which could design and implement a flexible and innovative IT platform to be used as the basis of the Space young people's programme in line with the specification provided.

The services of a local organisation, Netinspire based in Stoke-on-Trent have clearly demonstrated the ability to deliver against all requirements at a cost of £20,336 for an annual contract, with the ability to extend this year on year for a further two year period, enabling low level development costs (year two maximum £10,000, year three maximum £5,000).

#### Recommendation:

That NetInspire be appointed to develop, introduce and support the Space programme through development of the Space IT platform and marketing support.

#### PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

#### 1. Introduction and background

The Space positive activities programme for youngsters aged 11-17 years was introduced by the PCC in 2015, operating during the school summer holiday period as a proof of concept. Funded by the PCC with commissioning of provision by Local Authority partners, Space involved the provision of a range of diversionary activities to reduce levels of police recorded anti-social behaviour and youth crime, and to increase volunteering. Additionally Space aims to promote personal, health and social development, team building and new experiences.

Local needs for youth provision were identified by analysis of hotspot locations for ASB aligned to existing youth provision and local authorities commissioned services from local providers. Activities were made available universally to young people and also through a targeted approach, aiming to encourage participation by youngsters on the cusp of ASB / low level crime through

Learnings from the 2015 proof of concept approach were reflected in the 2016 programme which in turn was comprehensively evaluated with feedback from young people, providers, local authority commissioning partners and OPCC staff.

Key feedback included concern at the level and complexity of administration, monitoring and evaluation processes supported by the templated technological solution which was not considered flexible enough to adapt to identified requirements. Rigid templates defined the way data was captured, managed and could be interrogated and IT support requirements then placed significant burden on Staffordshire Police, being the only technical support available to the OPCC.

With limited technical experience in social media marketing, the OPCC recognised that opportunity to target key locations / hotspots / young people were not maximised, identifying this for future years as a key learning.

Costing £139,297.41, Space 2016 saw 12,432 young people engaging in positive activities, of which 1,114 were funded by the PCC over the five week summer holiday period.

Aiming to provide a holistic offer to young people of Staffordshire and Stoke on Trent, the Space website also provided detail of a further 1,968 non PCC funded activities which too were input and administered by the OPCC.

Recognising the feedback received, the need to develop an adaptable, flexible technical foundation on which to base future Space activity and the need to maximise use of social media marketing techniques, the OPCC needs to outsource this activity to secure best value services.

Given the low contractual value, a Request for Quotation process was put in place by IT Procurement to secure the services of an IT development service which could design and implement a flexible and innovative IT platform to be used as the basis of the Space young people's programme in line with the specification provided.

The services of a local organisation, Netinspire based in Stoke-on-Trent have clearly demonstrated the ability to deliver against all requirements at a cost of £20,336 for an annual contract, with the ability to extend this year on year for a further two year period, enabling low level development costs (year two maximum £10,000, year three maximum £5,000).
