I can confirm that the Staffordshire Commissioner's Office does hold the requested information.

This is an information request relating to size of offices, revenue and general staffing of your PCC office.

1. The total cost of the Police and Crime Commissioner's office in 2016-17, 2017-18, 2018-19, 2019-20, and 2020-21

There are no bonuses, or other in-kind benefits to add to the totals shown above, other than mileage. Mileage payments in line with Staffordshire Police terms and conditions are paid to recompense members of staff who use their car for work-related activities.

Please note that the years from 2018/19 include the addition of the Fire and Rescue Authority role and therefore, are not comparable with 2016/17 and 2017/18; the Police and Crime Commissioner took on this role from 1st August 2018.

Year on year comparisons are also impacted by inflationary pressures e.g. pay awards, tax changes and by funding regimes e.g. posts funded specifically by special grant, or by other organisations.
