Since 2020, the following buildings have been sold;

Tunstall Police Station	Sold on the 1 st July 2020 -	Value £200,000
Eccleshall Police Post	Sold on the 9 th December 2020	Value £200,000
Stone Police Station	Sold on the 12 th May 2021	Value £449,526.80
Tamworth Police Station	Sold on the 24 th June 2021	Value £900,000
Hanley Police Station	Sold on the 29 th April 2022	Value £1,250,000
Blythe Bridge Police Post	Sold on the 17 th October 2024	Value £387,600

- 2. List the buildings currently for sale by the force? And can you specify whether these are still currently in use or not?**

Uttoxeter Police Station is currently for sale. This site has been vacant since April 2025 and is fully decommissioned

- 3. List the new police buildings opened since the beginning of 2020 and state how much they cost to build?**

We have not built any new buildings since 2020

Freedom of Information Request Appeals Procedure



1. Who Can Ask for a Review

Any person who has requested information from the Staffordshire Commissioner's Office which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
