Summary:

The Commissioner is required to set the precept for Police & Crime before the start of the new financial year. In doing so he puts forward precept proposals to the Police, Fire and Crime Panel which they are required to consider. Under legislation the Panel has the power to veto the precept proposals if they deem them too high or too low.

The Police, Fire and Crime Panel registered their support for the Police and Crime precept on 5th February 2024. The proposal was for a 4.99% increase (£13) per annum, increasing the council tax to £273.57 per annum for a Band D property.

REPORT AND ADVICE TO THE STAFFORDSHIRE COMMISSIONER

1. Introduction and background

The Commissioner is required to set the precept for both Police & Crime and Fire & Rescue before the start of the new financial year. It is a legal requirement to set the precept in good time to issue council tax leaflets and bills for the forthcoming financial year.

In doing so he puts forward precept proposals to the Police, Fire and Crime Panel which they are required to consider. Under the Police Reform and Social Responsibility Act 2011, the Panel has the power to veto the precept proposals if they deem them too high or too low.

The Police, Fire and Crime Panel registered their support for the Police and Crime precept on 5th February 2024. The proposal was for a 4.99% increase (£13) per annum, increasing the council tax to £273.57 per annum for a Band D property.

The Panel confirmed their support in reports to the Commissioner. The Police & Crime report also noted the challenging financial position for Police and stressed that the transformation plans would be key to the budget proposals being delivered.

2. Issues for consideration

The issues are explored in the budget suite of documents which were presented to the Police, Fire and Crime Panel on the 5th February 2024.
