#### **Summary:**

The Commissioner is required to set the precept for Police and Crime, and Fire and Rescue before the start of the new financial year to the timetable set by the relevant legislation and regulations. In doing so he puts forward proposals to the Police Fire and Crime Panel which they are required to consider, and either support or not.

The Police Fire and Crime Panel registered their support for the Police and Crime precept on 1st February 2021 and for the Fire and Rescue precept on 15<sup>th</sup> February. They wrote to the Staffordshire Commissioner in support of the Policing and the Fire Precept increases. The Commissioner wrote back on both occasions noting the comments made by the Panel. The challenging financial position and the uncertainty around future funding that exists currently was recognised by the Panel.

#### Recommendation:

That the Police and Crime precept is set as £238.57 for a Band D property from 1 April 2021.

That the Fire and Rescue precept is set as £78.78 for a Band D property from 1 April 2021.
